Carolyn D. 'Crick' Moore

A celebration of life for Carolyn D. "Crick" Moore, 81, of Logansport, will be held at 11 a.m. Wednesday, Feb. 8, in St. James Lutheran Church.

She died at 2:30 a.m. Wednesday, Feb. 1, 2006, in Miller's Merry Manor.

Born Oct. 15, 1924, in Logansport, she was the daughter of Frederick and Lucile Barnes Drompp. She was married Sept. 4, 1948, in Logansport, to William E. Moore, who survives.

Crick was a lifelong member of St. James Lutheran Church. Over the years, she served on many boards and committees at the church, including the finance committee.

A 1946 graduate of DePauw University, she was a member of Kappa Kappa Gamma sorority.

Following graduation, she worked for the Red Cross in South Bend as a social worker until her marriage. She then worked as a teacher at Woodlawn Center, beginning in 1968, and worked up to program director and then executive director, a position she held for more than 15 years. During this period, she administered an annual budget that rose from \$160,000 to over a million and a quarter dollars per year.

In 1988, Crick received the annual award from the Indiana Association for Retarded Citizens for outstanding contributions to the field of mental retardation. Crick served on the Board of Directors for Indiana State Association of Executive Directors of Mentally Retarded Organizations. She also served as a member of the Private Industry Council that administered the Joint Training and Partnership Act. Crick was a member of the Board of Directors of the Cass County United Way and served as secretary on the Board of Directors of Little Turtle Waterway. She also was a volunteer driver to get cancer patients to treatment centers. In past years, Crick served on various boards such as Cass County Community Foundation, Cass County Family Y and the Cass County Red Cross. She was an honorary active member in Psi Iota Xi sorority.

Crick enjoyed traveling but most especially enjoyed her family.

Also surviving are sons, Bruce F. Moore and his wife, Theresa, Canal Fulton, Ohio, David Moore and his wife, Ruth, Whidbey Island, Wash., and Alan Moore and his wife, Tracy, Indianapolis; daughters, Susan VanDeman and her husband, Mark, Whiteland, Janie Sampson and her husband, Keith, Sisters, Ore., and Carolyn Burdsall and her husband, Mike, Danville; sisters, Joan McAfee and her husband, Bill, Pisgah Forest, N.C.; Judith Guild and her husband, Dr. Kent, Plymouth; two aunts, Virginia Kniesly, Logansport, and Doris Hillis, Bloomington; 19 grandchildren; one great-grandson; and a number of nieces and nephews.

Pastor Marvin Hinkle will officiate at the services. Burial will be in Mount Hope Cemetery.
